### **NOTICE OF THE OPENING OF THE SELECTION PROCESS FOR THE 2025 CLASS OF THE MASTER'S DEGREE IN FORESTRY SCIENCE AT UFAC**

The Coordination of the Graduate Program in Forest Science (PPG CIFLOR) of the Federal University of Acre (UFAC), in the use of its attributions and in accordance with the Regulations of the *Stricto sensu* Graduate Programs of UFAC, makes public the opening of the Selection Notice for the 2025 class in the Academic Master's modality. This Selection Notice was approved by the Program Board at its meeting held on November 13, 2024. The notice was drawn up with reference to CEPEX Resolution Nº. 242 of August 31, 2023.

#### **1 ABOUT THE MASTER'S COURSE IN FOREST SCIENCE**

The PPG Ciflor is an in-person *Stricto Sensu* academic postgraduate programme recognized by CAPES in December 2015. The program began its activities in 2016, and in view of the regional need for studies in the forestry area, it began its mission to train qualified personnel to generate scientific knowledge and promote the development of new technologies for the sustainable management of natural and planted forests in the region with a view to obtaining wood and non-timber products from activities that are environmentally correct, socially just and economically viable. The Ciflor PPG currently has a “3” rating in the CAPES Quadrennial Evaluation (2017-2020) in the area of Agricultural Sciences 1.

1.2 The PPG Ciflor confers a master's degree in Forestry Science on graduates with the aim of contributing to the production of knowledge in forestry science considering local specificities and regional issues by training human resources with the skills and competencies to produce, disseminate and apply knowledge in the implementation and

management of forests.

1.3 Specifically, the course aims to: i) Preparing people to carry out scientific research in natural and planted forests in order to improve sustainable forest management techniques, and ii) Socialize relevant results so that they can be incorporated into decision-making related to the development of forest management policies in the state.

1.4 The Ciflor PPG has two lines of research grouped together in the Forest Management Area, namely: i) Tropical Forest Management and ii) Forest Stand Formation and Management.

1.5 According to article 49 of CIFLOR's internal regulations: "The maximum and minimum duration of the Master's Degree in Forest Science will be 24 (twenty-four) and 12 (twelve) months, respectively, from the date of the first institutional enrollment". The number of credits required to complete the Master's Degree is 24. ## 2 VACANCIES

2.1 A total of eleven (11) places will be offered, eight of which will be open to the general public and three reserved for affirmative action, in accordance with Consu Resolution 162 of November 24, 2023. The distribution of places for affirmative action will be as follows:

2.1.1 Up to 20% of the total number of places (2 places) for black, indigenous and/or quilombola people, and for transgender people, in order to comply with the Affirmative Action Policy provided for in MEC Normative Ordinance N°. 13, of May 11, 2016 and State Law No. 3,722/2021.

2.1.2 Up to 5% of the total number of vacancies (1 vacancy) for people with disabilities (PwD), in order to comply with the Affirmative Action Policy provided for in MEC Normative Ordinance N°. 13, of May 11, 2016 and State Law N°. 3,722/2021.

2.2 In all cases, registered candidates must go through all stages and be approved in the selection process.

2.3 Black, indigenous, disabled and quilombola people, as well as transgender people, will compete concurrently for the places earmarked for affirmative policies and the places earmarked for broad competition, according to the availability of places and the descending order of approval and classification.

3.1 Registration for the selection process will only be carried out online during the period stipulated in the schedule, via the link: (<http://sistemas.ufac.br/ciflor>). All files must be sent in PDF format.

3.2 The candidate's registration in the notice for applications will imply knowledge and full acceptance of the conditions set out in this document, its Annexes and all subsequent modifications, in relation to which he/she cannot claim ignorance.

3.3 Documents required for registration of Brazilian candidates (digital files of the following documents in pdf format):

- ✓ File 01 - Completed application form (Annex I);
  - ✓ File 02 - Updated Lattes CV in PDF format, no larger than 5 megabytes. For foreign candidates, please refer to the CV template in Annex VII;
  - ✓ File 03 - Proof of the information contained in the Curriculum Lattes or Curriculum vitae (foreign candidates);
  - ✓ File 04 - Copy of official identification document with legible photo. For foreign applicants, a copy of their passport;
  - ✓ File 05 - Proof of being up to date with electoral obligations (Example: Electoral Discharge Certificate - <https://www.tse.jus.br/servicos-eleitorais/autoatendimento-eleitoral#/>);
  - ✓ File 06 - Proof of military service;

with Autism Spectrum Disorder (ASD), the medical report must have been issued within the last 12 (twelve) months prior to registration and provide a detailed report on the functional limitations inherent to the disability and its sequelae; ii) people with hearing impairment must present an audiometry test and a specific opinion with restrictions and/or recommendations; iii) people who are blind, monocular or have low vision must present an ophthalmological test showing visual acuity and a specific opinion;

- ✓ File 08 - For candidates competing for affirmative action vacancies for black, indigenous and/or quilombola, at the time of registration must present documents and it is necessary to sign the “Self-declaration of Color or Ethnicity” (Annex VI). Transgender candidates must submit a self-declaration to prove eligibility (Annex VIII);
- ✓ File 09 - For indigenous applicants only, it is necessary to submit a self-declaration (Annex VI) and a copy of the administrative birth registration (RANI) or a declaration of belonging issued by the indigenous group signed by a local leader;
- ✓ File 10 - Undergraduate transcript containing the value of the Coefficient of Performance or similar.

3.4 When registering, the candidate must select possible supervising professors. To do this, you must choose 3 (three) possible supervisors, in order of preference (1st, 2nd, 3rd) on the online Application Form. In order to select possible supervisors, the candidate must check whether the supervisor's “Research Area” is related or similar to the area in which the candidate intends to develop the dissertation. For this indication, it is necessary to look at the table of Areas of Activity, which lists the supervisors and their respective lines of research/areas of interest (Appendix II).

3.5 Information included in the Curriculum Vitae and not documented by means of copies of the supporting documents or documents sent which are not included in the

Curriculum Vitae will not be considered in the assessment of qualifications.

3.6 Applications with incomplete documentation will not be accepted. Candidates with incomplete documentation will be notified of the rejection of their application.

3.7 Candidates who require special assistance to carry out any of the stages of the selection process must state this need on the online registration form, so that the appropriate arrangements can be made.

3.7.1 When registering for the selection, applications for places for people with disabilities must provide information on the accessibility resources to be used in the entrance exams, in accordance with the provisions of Consu Resolution N<sup>o</sup>. 162 of November 24, 2023. Failure to provide this information when registering will mean that no accessibility resources will be offered.

3.8 Applications and the required documentation will be analyzed and approved by the Selection Committee and the list of successful applications will be made available on the internet at <http://www2.ufac.br/editais/propeg>, according to the schedule in this notice (item 5).

## **4 THE SELECTION PROCESS**

4.1 The selection process will be conducted by a committee set up by the CIFLOR Board, made up of professors who will be responsible for all stages of the selection process, comprising the following members: Eduardo Pacca Luna Mattar (President of the Commission), Evandro José Ferreira Linhares (member), Evandro Orfanó Figueiredo (member) and Paulo André Trazzi (alternate member). The members were appointed in accordance with Ordinance N<sup>o</sup>. 3323 of October 4, 2024.

4.2 The selection process will consist of (3) three stages, as follows:

**I- Stage 1 (Eliminatory):** Homologation of applications: this stage is eliminatory and aims to verify that the documentation required in item 3.3 has been fully complied with by the candidate. Candidates who do not meet this requirement will have their application rejected by the Selection Committee.

**II- Stage 2 (Eliminatory):** Written test of specific knowledge covering the two lines of research of the CIFLOR PPG. This evaluation will result in a grade from 0 (zero) to 10 (ten) points. The test will last a maximum of 4 (four) hours, according to the schedule in this notice. Candidates will not be allowed to enter after 15 minutes from the start of the test. The presentation of an official photo ID is mandatory to take the exam. Candidates who score less than 5 (five) points will be eliminated from the competition.

**III- Stage 3: (Qualifying):** Analysis and evaluation of the Curriculum Vitae considering the production of the last 5 complete years (from the date of publication of the notice) in the model of the Lattes Platform - CNPq or the model for foreigners according to Annex VII of this notice. The score will be based on the Scoring Table in Annex III of this notice. Only candidates approved in the 2nd Stage will be evaluated at this stage. This evaluation will result in a score of 0 (zero) to 10 (ten) points.

4.3 The final grade for the selection process for admission to PPG Ciflor will be obtained using the following equation:

$$\text{Final grade} = \frac{[(\text{Test grade} \cdot 7) + (\text{Titles grade} \cdot 3)]}{10}$$

4.4 The classification of successful candidates will be based on the descending order of final grades, up to the limit of the number of places available;

4.5 Taking the exam outside the municipality of Rio Branco is subject to a formal request from the candidates to the committee via the official PPG Ciflor e-mail ([ppg.ciflor@ufac.br](mailto:ppg.ciflor@ufac.br)). The selection committee will decide whether this is feasible, and whether there is any prejudice to the other provisions of this notice.

4.6 In the event of a tie in the candidates' final scores, the tie-breaker will be based on the criteria listed below, in the following order:

- 1º Obtains the highest mark in the Eliminary Written Test of specific knowledge;
- 2º Obtains the highest score in the Titles Test - Analysis and classification of the Curriculum Vitae;
- 3º Having the highest academic performance coefficient or similar obtained from the Academic Transcript;
- 4º Being the oldest.

6.2 The appeal must be justified and objectively state the point on which the request is based. The appellant must set out the grounds for the request for review in a clear and objective manner, and may attach any documents he or she deems relevant. Under no circumstances will the committee accept requests to review the results of appeals filed by candidates. Appeals whose content disrespects the fairness of the selection process will be rejected.

## 7 REGISTRATION

7.1 The institutional enrollment of the selected candidates will be carried out at the UFAC Academic Registration and Control Center (NURCA), on the days to be determined by the call notice virtually via the institutional email: [matricula@ufac.br](mailto:matricula@ufac.br). Normative Instruction - NURCA N<sup>o</sup>. 01/2023, of August 4, 2023, must be taken into account for registration.

7.1.1 At the time of institutional registration, the following documents will be required of the selected Brazilian candidates:

- a) a copy of the diploma of completion of the undergraduate course in the areas of Forestry Engineering or related areas, or Certificate/Declaration/Documentation proving that the candidate is in a position to graduate by the date of institutional enrollment of those approved in this selection process.
- b) Identification document with photo, containing the CPF number;
- c) Individual Taxpayer's Register (CPF) if its number does not appear on the identification document;
- d) Proof of discharge of electoral obligations (voter registration and proof of voting or electoral discharge certificate);
- e) up-to-date proof of residence (last three months);

f) proof of military service, for successful male candidates.

7.1.2 At the time of institutional registration, the following documents will be required of the selected foreign candidates:

- a) Proof of schooling (graduation), duly translated, legalized or apostilled in accordance with the Hague Treaty;
- b) National Registration of Foreigners - RNE, with the possibility of presenting a passport in cases defined as emergencies, and the selected candidate must present the RNE until the end of the course.
- c) Up-to-date proof of address (last three months);
- d) Exceptional cases will be assessed by the Academic Registration and Control Center (NURCA).

7.2 In the case of successful candidates who have an employment contract, they must submit a statement of release from their employer (Annex IV) to the CIFLOR Secretariat.

7.3 The approved candidate who does not present the documentation referred to in the previous items will have his/her registration rejected, and the next candidate on the waiting list will be called.

7.4 Curricular registration must be carried out at the Ciflor PPG Secretariat, in person, on the days set out in the schedule in item 6 of this notice or in a call notice, which will be published on the same day as the final result.

7.5 Upon the curricular registration, all candidates must submit the Commitment Agreement (Annex V).

8.2 PPG Ciflor does not guarantee scholarships. However, in the event of scholarships becoming available, approval and distribution will be made by the scholarship committee in accordance with criteria established by the committee itself and in compliance with the criteria defined in Ordinance N<sup>o</sup>. 076 of April 14, 2010, the CIFLOR regulations and Joint CAPES-CNPq Ordinance N<sup>o</sup>. 01 of July 15, 2010.

8.3 The selected candidate who has an employment relationship must present, at the time of enrollment, a statement from the employer stating that he/she will be released to participate in the course (Appendix IV). Failure to present this document will result in the denial of enrollment. However, it is hereby established that, even with the statement of release, if during the course there is no effective release, the student may be dismissed at any stage of the master's degree course, even after confirmation of institutional and curricular enrollment.
